The Open Meetings Act requires new members of governmental bodies that are subject to the Act—including new Board members—to participate in education training sessions within 90 days of taking the oath (or otherwise assuming the responsibilities) of office. This training session has been approved by the Office of the Attorney General to meet this requirement, and Board members attending this session will obtain the required certificate of completion, thus allowing both Board members and their Boards to meet the Open Meetings Act training requirements.

Imagine what you could accomplish if you could decode the mystery of human behavior and truly understand what makes people do what they do and say what they say (including yourself!). Research shows that the number one key to success in any industry or organization is the ability to get along with other people, personally and professionally.
