### RESEA Program Purposes

### **Employment Outcomes:**

 Reducing Unemployment Insurance duration by providing UI claimants with intensive employment services and valuable resources to assist Texans in getting back to work quickly with emphasis on sustained employment

### Program Integrity:

 Protecting Unemployment Insurance benefits through prevention of improper payments and enforcement of program requirements

#### Connect to WIOA:

 Identifying eligible Texans for additional career training services and providing personalized guidance to help enhance skills and achieve employment goals


### Entry point to other Services:

Referrals to Vocational Rehabilitation and Veteran Services

# Funding Trend

#### **RESEA Funding Growth Since Program Inception**

Program funding has increased by over 230% in seven years.



# **Funding Categories**

#### **Base Funding**

- Base grant allocation DOL awards to Texas
- Funds
  - TWC administration and oversight
  - Program implementation (Grants awarded to Boards)
  - Program Evaluation up to 10%
  - Innovations and Initiatives
- Funding allocation has increased over 230% from FY2018 to FY2025.

#### Additional Allocation


- Unused RESEA funds from other states reallocated to other states by request
- Texas has received additional funds in FY2023 and 2024
- Additional allocations have been used to fund implementation of subsequent meetings

#### Outcome Payment

- Outcome payments-based on meeting two RESEA performance targets established by DOL each year:
  - UI Duration
  - Reemployment Rate
- Texas has earned outcome payment for three consecutive years

### Performance Trend

In FY2021, DOL establish the RESEA completion rate (the percentage of customers profiled that completed the initial RESEA appointment) as an indicator of successful program implementation. The Commission established a completion target of 77% for Boards and Boards continue to perform in an upward trend towards the target
