FOOD STAMP EMPLOYMENT AND TRAINING** 2 3 **PROPOSED RULES WITH PREAMBLE TO BE SUBMITTED TO THE TEXAS** 4 **REGISTER.** THIS DOCUMENT WILL HAVE NO SUBSTANTIVE CHANGES BUT IS 5 SUBJECT TO FORMATTING CHANGES AS REQUIRED BY THE TEXAS REGISTER. 6 7 The Texas Workforce Commission (Commission) proposes the repeal of the following sections 8 of Chapter 813 relating to Food Stamp Employment and Training: 9 10 Subchapter F, Complaints and Appeals, §813.51 and §813.52 11 12 PURPOSE, BACKGROUND, AND AUTHORITY PART I. 13 PART II. **EXPLANATION OF INDIVIDUAL PROVISIONS** 14 PART III. PURPOSE, BACKGROUND, AND AUTHORITY 18 The purpose of the proposed rule change is to establish detailed and consistent procedures for 19 complaints, hearings, and appeals related to workforce services administered by Local 20 Workforce Development Boards (Boards). Texas Labor Code §302.065 requires that the 21 Commission integrate the administration of multiple federal block grant programs and identify policy changes that support this integration. The Commission expanded this integration to state-22 23 funded workforce services, including examining the existing complaints and appeals processes 24 for workforce services administered by the Boards. An absence of unified and integrated rules 25 on complaints, hearings, and appeals related to workforce services makes the existing rules 26 difficult to understand or interpret consistently and works as a barrier to integrating workforce 27 services. 28 29 To maintain uniformity and consistency across all Board-administered workforce services and to 30 protect due process rights of Texas Workforce Center customers, in a separate, but concurrent, 31 rulemaking proposal, the Commission is proposing the repeal of Chapter 823, General Hearings 32 rules, and is proposing new Chapter 823, Integrated Complaints, Hearings, and Appeals rules. 33 New Chapter 823 requires Boards to establish local policies for filing complaints, to provide 34 opportunities for informal resolutions, and to establish procedures for Board hearings and 35 appeals. 36 37 The Commission has reviewed sections of Chapter 813 relating to complaints or grievances, 38 local-level appeals, and state-level hearings. The Commission proposes to repeal these sections 39 and incorporate similar processes related to complaints, hearings, and appeals in new Chapter 40 823. 41 42 PART II. EXPLANATION OF INDIVIDUAL PROVISIONS 43 44 SUBCHAPTER F. COMPLAINTS AND APPEALS 45 The Commission proposes amendments to Subchapter F, as follows: 46

1 2	Under a separate, but concurrent, rulemaking proposal, the Commission is proposing new Chapter 823, Integrated Complaints, Hearings, and Appeals, which comprises the complaint,
3	hearing, and appeal procedures for all Board-administered workforce services, including the
4 5	information in the following sections.
6	§813.51. Appeals of Decisions Made on Food Stamp Applications and Benefits
7 8	Section 813.51 is repealed and the information is relocated in new Chapter 823.
9	§813.52. Appeals of E&T Activities and Support Services Decisions
10 11	Section 813.52 is repealed and the information is relocated in new Chapter 823.
12	PART III. IMPACT STATEMENTS
13	Randy Townsend, Chief Financial Officer, has determined that for each year of the first five
14 15	years the rules will be in effect, the following statements will apply:
16	There are no additional estimated costs to the state and local governments expected as a result of
17	enforcing or administering the rules.

19	There are no estimated reductions in costs to the state and to local governments as a result of
20 21	enforcing or administering the rules.
22	There are no estimated losses or increases in revenue to the state or to local governments as a
23 24	result of enforcing or administering the rules.
25	There are no foreseeable implications relating to costs or revenue of the state or local
26	governments as a result of enforcing or administering the rules.
27	
28 29	There are no anticipated economic costs to persons required to comply with the rules.
30	There is no anticipated adverse economic impact on small or microbusinesses as a result of
31 32	enforcing or administering the rules.
33	Mark Hughes, Director of Labor Market Information, has determined that there is no significant
34 35	negative impact upon employment conditions in the state as a result of the rules.
36	Laurence M. Jones, Director, Workforce Development Division, has determined that for each
37	year of the first five years the rules are in effect, the public benefit anticipated as a result of
38	enforcing the proposed rules will be to provide a unified and streamlined process regarding the
39	resolution of complaints, hearings, and appeals related to Board-administered workforce
40	services. In addition, due process principles and other legal rights will be protected, program
41	outcomes will be achieved more effectively, and workforce services will be further integrated.
42	
43	The Agency hereby certifies that the proposal has been reviewed by legal counsel and found to
44	be within the Agency's legal authority to adopt.

4 5 6 7	Applicants and recipients of Food Stamp benefits may appeal adverse action taken on their application for benefits or the amount of benefits to the Department of Human Services (DHS) in accordance with DHS rules pursuant to 40 TAC §3.2406 of this title (relating to Right to Appeal).
8	<b>§813.52.</b> Appeals of E&T Activities and Support Services Decisions.
9 10 11	(a) Boards shall ensure that mandatory work registrants participating in E&T activities are informed of their rights to appeal a decision related to E&T activities and support services and the procedures for requesting a fair hearing.
12 13 14	(b) E&T mandatory work registrants who are dissatisfied with E&T decisions affecting E&T activities or support services may have an informal review of these decisions through procedures established by the Commission or Boards.
15 16 17 18 19 20	(c) Mandatory work registrants may also file an appeal of the decision under the general hearings process as contained in the Commission rules in Chapter 823 of this title (relating to General Hearings). The request must be submitted in writing to the Appeals Department, Texas Workforce Commission Building, 101 East 15th Street, Room 410, Austin, Texas 78778-0001, within 30 calendar days of the date of the decision.
