- 4 On August 28, 2018, the Commission approved a target methodology for the Employer Workforce Assistance (EWA)
- 5 measure for staff to apply for Board Contract Year 2019 (BCY19). Normally this measure's performance period runs
- 6 October to September which for BCY19 would mean October 2018 to September 2019. Unfortunately, while the new
- WorkInTexas system offered a number of significant benefits to employers and job seekers, the employer service data
  - used for the EWA measure is structured rather differently than the way it was in the old WorkInTexas system. While we
  - anticipate being able to reconcile the differences, we don't anticipate doing so in time for BCY19 yearend reporting at
  - the end of October.

## **BCY19 Adjustments**

- Staff recommend 2 adjustments to related to the Employer Workforce Assistance measure for BCY19:
  - 1) We recommend changing the performance period to be modified to August 2018 to July 2019 to ensure we have fully comparable data across the period; and
  - 2) We recommend adjusting Board targets by taking a weighted average of their BCY18 and BCY19 local targets. Shifting the performance period essentially means we have a performance period that is 2 months of BCY18 and 10 months of BCY19 so we will blend the targets according to those ratios (results shown on page 2).

## **Commission Request**

<u>Staff request the Commission approve the modifications to the BCY19 Employer Workforce Assistance performance</u> period and local targets using the methodology outlined above and detailed on page 2.
