19	with them claiming that I had misconduct, because I went two
20	levels above I went above I went to my res lead,
21	nothing was done, I went to my team lead, nothing was done,
22	I went to the operations manager, nothing was done. Saying
23	that the team lead had an anger management question, and
24	also I beg that you re-read the transcripts, because as I
25	asked the, I don't know, person who was negotiating the

1	hearing, I said: Look, you know, Convergys, my team lead and
2	the HR manager are just lying left and right. Are there no
3	consequences for their committing perjury on several points?
4	My team lead was Eric and a different one
5	had the anger management issue but he said that I read
6	the info from the tracking info on the delivery company and
7	then offered the customer a delivery company's direct
8	contact info for follow up, as I was trained to do and
9	directed to do. He also said that we, as Google, provide
10	shipping, which we don't. We have third-parties that do
11	that, and I had to explain that because they were lying
12	again.
13	The HR manager made personal character
14	attacks on me and the person who was negotiating the hearing
15	didn't say anything about that, and that was completely out
16	of line. I had a witness who backed up my testimony and
17	then in the second hearing that I called my team lead, Eric,
18	said that I never read the info and I hung up on the
19	customer, and then he said that we didn't do the delivering.
20	Basically I would beg that you listen to the
21	tapes again, or the CD I have them with me and you
22	will see for yourselves that the Convergys HR representative
23	and the team lead, Eric, were both lying and they committed
24	perjury on several occasions, and my witness supported that
25	I was definitely following procedure.

7	she real it was an emergency and her elderly mother

12	her, and they're calling that misconduct. I did everything
13	by the book even though they went over Google's code of
14	conduct, where they didn't go over Convergys' code of

16	times because there were several mistakes and they just
17	said: Oh, just sign it. So, I did, and here I am.

18	Mr. O'BRIEN: All right. Well, good morning,
19	commissioners, and Mr. Serna. For the record, my name is
20	Reed O'Brien, Workforce Division. And just so you are
21	aware, I will be seeking direction on two decision points.
22	On January 29, 2019 the commission approved
23	the awards and reward amounts to be presented at this year's
24	workforce conference, and future workforce conferences.
25	During that meeting the commission requested staff to

1	develop an award that recognizes board for their
2	achievements in developing and expanding registered
3	partnership programs within their local workforce
4	development areas.
5	Staff has developed a nomination-based award
6	called the Registered Partnership Expansion Award, and
7	that's to be presented to up to three boards in the amount
8	of \$100,000 each as outlined in the discussion paper.
9	Also, on January 29th the commission approved
10	the measures for two awards; the Workforce Innovation and
11	Opportunity Act Career Pathways Award, and the AEL Best in
12	the Class Performance Quality Improvement Award. Winners
13	for both of those awards will be determined by performance
14	data. The recommended weights to the performance measures
15	are outlines in your discussion paper.
16	At this time staff seeks direction on the
17	first of two decision points, and would the commission like
18	to address those two decision points as separate votes?
19	CHAIR HUGHS: If that's easier for staff, we
20	and proceed that way.
21	MR. O'BRIEN: Okay, thank you. First, staff
22	seeks direction on establishing the new board award, the
23	Registered Partnership Expansion Award, to be presented to
24	up to three boards in the amount of \$100,000 each in
25	recognition of a board's achievements in developing and

1	expanding registered apprenticeship programs in their
2	workforce areas. And that's to be presented at the 2019
3	Texas Workforce Conference and future workforce conferences.
4	I'll be happy to answer any questions.
5	CHAIR HUGHS: Commissioners, do you have any
6	questions or comments? Okay. I have one before we vote,
7	and that is that I am supportive of the award. I
8	particularly like the word expansion, because I do think
9	otherwise we're handing out an award to the larger employer
10	boards that have registered apprenticeships already. And
11	so, the fact that we'll expand the program, I think is the
12	point of the award, and I'm supportive of that.
13	I am concerned when I look at the award
14	amounts for other awards, that there is a large disparity.
15	And, no, we're not trying to in any way incentivize, say,
16	this over foster care youth or higher ability or many of the
17	other awards, AEL, et cetera. So, I'm a little worried
18	about the large disparity and the amount of money. And so,
19	I would support this for 2019, but I would ask that we
20	really look at 2020 to make sure that our award amounts are
21	in parody.
22	But with that, if anyone has a vote they'd
23	like to put on the record, we can entertain that now.
24	MR. ALVAREZ: I'd like to put a vote.
25	CHAIR HUGHS: I'll say on the record. For

1	example, we have awards where three awards have a total of
2	\$100,000; 50, 30 and 20. But for apprenticeships we have
3	100, 100 and 100, and that's the only area where I have
4	concern. Certainly, support the effort.
5	COMM. THOMAS: I support the effort, and I
6	believe that it's critical, but I do appreciate what the
7	chair is saying. I'd like to maybe it would just be
8	appropriate, appropriate and since I'm the new guy still, I
9	get to say that for a while. Right? If maybe I could just
10	have a briefing on the analysis of how those tiers are
11	established in a different context.
12	MR. O'BRIEN: Yes, sir.
13	COMM. THOMAS: But otherwise I fully support
14	this.
15	MR. O'BRIEN: Yes, sir.
16	CHAIR HUGHS: Okay. Do we have a motion?

18	Chairman, can we have Courtney come in? I mean, we've had
19	numerous discussions, and on regarding this. And I also

24	MS. ARBOUR: Sure. Good morning. Courtney

1	awards was tailored after the Youth Inspiration Award, which
2	is self-explanatory, and it is also three awards at \$100,000
3	each. You all recently took an action to eliminate two of
4	the awards and replace with some others, and in doing that
5	you return \$120,000 to the statewide fund. So I just wanted
6	to mention that, that 120 was returned to the fund, and then
7	this would bring 300,000 into the picture for total award
8	amounts.
9	I also wanted to mention something, Chair
10	Hughs, to your earlier comment about indefinitely each year
11	when the operating budget is presented to you all for a
12	vote, these awards are a leg out, and you have an
13	opportunity each year to consider the amounts for this and
14	all of the other awards. So even if the if the amount is
15	approved, regardless of the amount you approve today, you'll
16	have an opportunity each year to consider the amounts for
17	this and all of the other awards, so even if the if the
18	amount is approved regardless of the amount you approve
19	today you'll have an opportunity each year to consider
20	whether you want to stick with that amount or change it for
21	future years.
22	CHAIR HUGHS: Thank you for that
23	clarification.
24	COMM. THOMAS: Thank you, Ed. In light of
25	that clarification. Thank you, Commissioner Alvarez, that

For the record, my name Chuck 21 Ross, Deputy Director of Regulatory Integrity Division. 22 At the February 26th public meeting you all voted for staff to move forward with proposed rules as 23 24 outlined in the policy content presented to you. 25 Specifically amending chapter 821 to conform with statute by Verbatim Reporting & Transcription, LLC 281.724.8600

1	clarifying that a wage claim may be withdrawn only when the
2	order has not yet become final.
3	During that meeting staff also saw the second
4	decision with respect to whether staff should pursue
5	additional investigation and legal analysis with respect to
6	a conditional bad faith penalty in instances where a wage
7	order is final, and the employer has not paid the wages
8	within a specified time frame. In such cases the penalty
9	would be invoked, and the agency wouldn't pursue collection
10	actions.
11	I am here today to clarify that the second
12	vote at the February 26th meeting.
13	CHAIR HUGHS: Well, I understand there's a
14	request to vote on the second portion again if anyone has
15	any comments or questions they'd like to put it on record,
16	or can take a vote. Yeah. I could tell you
17	I will maintain my previous vote.
18	COMM. THOMAS: What was your previous vote?
19	CHAIR HUGHS: So, I voted in support of this.
20	You might recall I had asked for OGC to get a memo
21	clarifying on the requirement to have a wage claim penalty
22	and they came back with an analysis that it's permissive and
23	that they can evaluate these to determine whether the
24	employer should, in fact, have a penalty invoked or not.
25	And I think that allows for sufficient consideration of good

1	will and provides an opportunity for an employer to do the
2	right thing. But also provides the opportunity to penalize
3	the employer if they haven't. I mean, it's permissive, is
4	what OGC came back with, and I support the rule as supported
5	by staff.
6	But I understand that there may have been
7	someone who voted differently that wanted to amend their
8	vote, so it was asked to be brought back. Is that correct,
9	Mr. Ross?
10	MR. ROSS: That's my understanding about
11	that.
12	CHAIR HUGHS: Okay. So, with that, is there
13	any is there a vote on the second portion of this matter?
14	I guess do you want we'll just take the vote again.
15	MR. ROSS: Yes ma'am.
16	CHAIR HUGHS: Okay. Does anyone have a vote
17	on the second part?
18	COMM. ALVAREZ: Madam Chair, so my vote on
19	the second decision Chuck and thank you for being here.
20	The current application of the Bad Faith Penalty Provisions
21	assumes that the employer had an opportunity to comply what
22	the payday loan, but instead, knowingly and recklessly
23	disregarded the law. I can see no good reason to give such
24	an employer further opportunity to avoid penalization. Such
25	would encourage unscrupulous employers to see withholding of

1	wages in wages in bad faith as a vis viable strategy
2	for managing labor cost and it will shift great pressure
3	onto claimants who have rightful wage claims.
4	For these reasons I cannot agree to the

13	recommendations for Fiscal Year 2020. The proposal calls
14	for reducing regular non-defensive discretionary spending by
15	9 percent from the current levels. For the Department of
16	Labor the proposal provides for 1.2-billion in spending for
17	Fiscal Year 2020, with a decrease of 9.7 percent from Fiscal
18	Year 2019 enacted levels.
19	The proposal does include investment of 160-
20	million in apprenticeship increased funding for the
21	transition assistance program establishing an unemployment
22	insurance solvency standard and a 1-million, one-time
23	mandatory investment for states to build a supply of
24	childcare and stimulate employer investment in childcare.
25	The complete summary of the President's

1	proposal has been provided to you all. Moving on to the
2	Texas legislature, last Friday was a deadline to file bills
3	for the 86 th legislative session. Of the 15 legislative
4	proposals adopted by the commission 10 have been filed this

6	improved overpayment recovery, the reform of the payrolling
7	rule, misclassification, emergency evacuation discrimination
8	complaints, fair housing act amendments, consolidation of
9	annual reports, earning statement requirement,
10	redetermination by examiner, removal of the unconstitutional
11	provisions of the Texas payday law, and wage claim
12	confidentiality.
13	A complete listing of all the individual
14	bills associated with these legislative proposals has been
15	submitted to you all. This concludes my remarks and I'm
16	happy to answer ay questions you may have.
17	CHAIR HUGHS: Any questions? Okay? None?

7	they need. So, they're all working very hard.
8	We were kind of bracing ourselves for a
9	pretty high volume in bills on the last day of filing. It
10	came in less than what we expected, but still a high number,
11	and staff is diligently going though all of those very
12	effectively.
13	The second thing is, it may seem like it's
14	very far off, but I want to remind the commissioners that
15	the Texas Science and Engineering fair hosted by Texas A&M
16	University will be held March 29th and 30th, so just make
17	sure that you all are aware of that. And other than that,
18	anything else that you all need from me, I'll continue to be
19	available to you.
20	CHAIR HUGHS: Thank you. Commissioners?
21	Anything on that? Okay. Thank you. And Thank you for
22	no, go ahead.
23	COMM. THOMAS: I no. I was just making
24	sure you were Ed, I would just like an updaters on the
25	things that I asked to be referred to staff, and to add to

1 that, there are two programs that were transferred to us in 2 recent years, the vocational rehab and purchasing from 3 people with disabilities.

If you, sir, could please look into developing a 9 pilot program that would incorporate some services and 10 resources from these two programs. I'd like to know what's 11 possible and to hear back on the outcomes of the -- of any 12 project in order to better inform decision making for these 13 valuable programs in the future.

14 I know you've been working with my staff and 15 having discussions on that, and we realize that per our commission-agreed process, that that should have been 16 17 brought to you from the dais, so thank you for your help on 18 that historically, but I wanted to make sure we communicated 19 that, Chair Hughs, from the dais. So, you all are fully aware of that. 20 21 MR. SERNA: Yes, sir. We appreciate that, 22 and we continue to work on that. 23 COMM. THOMAS: Thank you. 24 CHAIR HUGHS: Ed, something else I think is

important for the benefit of the agency is that last week we

2	regarding open meetings. It actually doesn't apply to our
3	agency in the sense that it was regarding when less than a
4	quorum meets, which for our purposes would be one of us
5	speaking to ourselves. But, having said that, I think it's
6	incredibly important to note legislations in past to address
7	the part that was struck down. And more importantly, it's
8	something that only the three of us have the benefit of, is
9	that every appointee of the governor got a letter from the
10	governor when that ruling was passed down.
11	And I want to share it with the agency,
12	because it's so incredibly important in the integrity of the
13	system that we have and the public transparency that we hold
14	dear, and I think that the letter really highlights the
15	governor's commitment to that as well. It says: Dear
16	appointees and state agency heads. So, you may have
17	received it as well, Mr. Serna. Texans place significant
18	trust in their elected and appointed officials. With this
19	trust comes the expectation that officials will conduct
20	public business responsibly and in accordance with the law.
21	One such law is the Texas Open Meetings Act,
22	which represents a commitment to the citizens of Texas that
23	the public's business will be conducted out in the open.
24	Texas has long been, and will continue to be, a leader in
25	governmental transparency.

2	has today declared section 551.143 of the Texas Open
3	Meetings Act unconstitutional, all other provisions of that
4	statute remain valid and binding. Regardless of yesterday's
5	ruling, my standard of expectation is for all agencies and
6	boards to continue to follow the spirit of the law. You
7	should not waver in your commitment to providing
8	transparency in the work you perform for Texans at your
9	respective governmental entities. Sincerely Governor Greg
