3	Other State Level Fund - Texas Career Signing Day. Jennifer
4	Troke. Good morning.
5	MS. TROKE: Good morning Chair Hughs,
6	Commissioners and MR. Serna. For the record, Jen Troke,
7	Workforce Division.
8	Bear with me, this one's a little bit long.
9	In January, Commissioner Thomas directed staff to develop a
10	statewide Signing Day initiative that boards and other TWC
11	partners may participate in. Since that time, Texas' first
12	ever Career and Technical Education Signing Day was held on
13	Tuesday, March 5, 2019, at TWC, and it celebrated four
14	student scholarships to attend Lamar Institute of
15	Technology.
16	Texas Career Signing Day is a proposed new
17	statewide initiative that provides an opportunity for TWC to
18	recognize and celebrate high school students choosing to
19	enter career pathways leading to in-demand careers and
20	targeted occupations directly from high school.
21	Texas Career Signing Day events celebrates
22	students moving up and along a variety of career pathways,
23	including entry into the workforce as a result of completed
24	career certifications towards targeted occupations, an
25	applied learning opportunity, like an internship, or

1	apprenticeship, a career and technical education program, or
2	some combination of all of the above.
3	Organizations participating in Texas Career
4	Signing Day Events or organizations that support skills
5	development for Texas youth, and may include workforce
6	boards, organizations serving high school students,
7	educational partners and employers in local businesses and
8	various communities.
9	TWC is interested in hosting Texas Career
10	Signing Days in May and June 2019, and will be inviting
11	interested organizations to participate in a webinar to
12	launch the initiative on April 18, 2019. Participating
13	organizations will receive a customizable, branded, and
14	downloadable toolkit that includes templates for
15	invitations, frameable certificates, media relations guides,
16	and event planning checklist. Finally, TWC will gather
17	lessons learned from piloting this initiative in 2019 and
18	share this information with commissioners for further
19	discussion about needed changes going forward.
20	Staff seeks direction on piloting this new
21	initiative, Texas Career Signing Day, in May and June of
22	2019, for all organizations willing to promote and celebrate
23	Texas high school seniors moving up and along in a variety
24	of pathways and secure gainful employment lead productive,

18	support students going into career technical fields, or any
19	other pathway, we often hear that people feel the pressure
20	to go one direction, and otherwise it's seen as less than or
21	failing. And I think as a state we recognize that we need
22	to really define what success means, and that it means lots
23	of different pathways. And these are pathways that are very
24	important, and that we're happy to support. I will say that
25	I've appreciated the opportunity to observe Skills USA, some

8	boards in support of Hurricane Harvey recovery. DOL
9	approved and awarded \$5-million grant modification to TWC
10	last week, along with an extension of the grant award
11	through December 2019. As noted last week, boards are near
12	exhaustion of their current funds, and require funds to
13	continue temporary work participants who are providing
14	needed disaster relief to their communities.
15	Staff seeks direction on approving additional
16	funds for the form most impacted board areas including 1.5-
17	million for Coastal Bend, 352,000 for Golden Crescent, 2
18	point 2,538,000 for Gulf Coast, and 610,000 for Southeast
19	Texas. Any questions?
20	COMM. ALVAREZ: No questions.
21	CHAIR HUGHS: Commissioners, any questions or

18	Greg Bon and Sarah Davis, Oscar Longoria and Armando Walle.
19	The Senate is expected to name their conferees on House Bill
20	1 sometime this week.
21	Yesterday, the Senate Natural Resources and
22	Economic Development Committee reported four of TWC's
23	legislative proposals from committee to the local and
24	uncontested calendar.
25	Those were Senate Bill 1500 by Senator
	Verbatim Reporting & Transcription, LLC 281.724.8600

1	Zaffirini, which is TWC's legislative proposal on the
2	removal of the unconstitutional provision from the Texas
3	Payday Law.
4	Senate Bill 2077 by Senator Paxton, which is
5	TWC's proposal for redetermination by examiner.
6	Senate Bill 2152 by Senator Zaffirini, which
7	is TWC's proposal related to wage claim confidentiality and
8	Senate Bill 2296 by Senator Powell, which is TWC's proposal
9	related to reform of payrolling.
10	We also have agency staff serving as resource
11	witnesses on two bills this morning before the House Human
12	Services Committee. Courtney Arbour will be serving as a
13	resource witness on House Bill 2866 by Representative
14	Deshotel, which relates to investigation and evaluation
15	information regarding certain childcare facilities, homes
16	and programs.
17	Cheryl Fuller will also be serving as a
18	resource witness on House Bill 3669 by Representative
19	Guillen, which relates to services provided to and
20	collection of data regarding individuals with an acquired
21	brain injury.
22	And finally, tomorrow, Carry Ballast (ph)
23	will be serving as a resource witness before the Senate
24	Natural Resources and Economic Development Committee on
25	Senate Bill 1055 by Senator Zaffirini. Senate Bill 1055

The request and hope is 10 that we could, Courtney, engage in kind of a survey across 11 other states what they may or may not be doing best 12 practices, and see if there's something that we could add to 13 our tool chest of childcare services along this line. 14 MR. SERNA: Yes, sir. We'll get on that. 15 COMM. THOMAS: Thank you so much, Ed. 16 CHAIR HUGHS: Commissioner Alvarez, anything? 17 I do want to mention on the childcare. I know our rules 18 require us to have a TRS Stakeholder Meeting, so I just want 19 to mention for the benefit of my fellow commissioners.
