18 19 20 21 22 23 24	Each year, the Texas Workforce Commission (TWC) establishes a methodology to distribute a portion of the Performance Outcome Payment to the Local Workforce Development Boards (Boards) as performance incentives based on their RESEA monthly completion rate. Establishing a performance activity—based distribution method for the RESEA program aligns with TWC's objective to emphasize highly successful efforts at the local level that benefit core customers.
25 26 27 28	Issue 1: Reallocation of FY 2023 Performance Incentive Balances to BCY 2025 The FY 2023 performance incentives to Boards for Board Contract Year 2024 (BCY 2024) were distributed in August 2024. Three Boards (Panhandle, Concho Valley, and Deep East Texas) were unable to fully expend funds by the contract end date of February 2025.

Issue 3: Additional Customers in the Profile Pools

DOL requires states use a portion of their FY 2024 performance outcome payment to increase the number of customers selected for RESEA. At the end of FY 2025 Q1, staff noticed a marked increase in the number of customers profiled for RESEA. The trend continued in Q2. To meet the requirements of the grants, staff developed a distribution

methodology to distribute a portion of the performance outcome payment to Boards that are experiencing increases in their profile pools.

Decision Point 3

Staff recommends amending the BCY 2025 contract to allocate \$1,290,114 of the FY 2024 Performance Outcome Payment to Boards for the provision of services to additional customers in their profile pools, as listed in chart below, as well as requiring that funds be expended by February 28, 2026. The remaining balance (\$8,293) of the \$2,880,907 outcome payment, will be allocated to TWC's RESEA administration.
