4	Background
5	In Fiscal Year 2021 (FY 2021), the U.S. Department of Labor (DOL) established a
6	Performance Outcome Payment program for the Reemployment Services and Eligibility
7	Assessment (RESEA) program. For FY 2024, TWC has received a Performance Outcome
8 9	Payment in the amount of \$2,880,907.
10	On July 8, 2025, TWC's three-member Commission approved the distribution of \$1,582,500
11	of the FY 2024 Performance Outcome Payment to Boards as performance incentives.
12	, i
13	Issue
14	DOL has added a requirement that states use a portion of their FY 2024 performance
15	outcome payment to serve additional RESEA customers. At the end of FY 2025 Q1, staff
16	noticed a marked increase in the number of customers profiled for RESEA, and this trend
17	continued in Q2. To ensure that Boards that are experiencing increased outreach pools have
18	enough funds to serve the additional customers, and to meet the DOL grant requirements,
19	staff developed a distribution methodology to distribute additional funds to those Boards
20	that need additional staff (based on the average capacity for a single RESEA staff person of
21 22	20 customers per week) to serve the additional customers in their profile pools.
23	The distribution amount for the Boards recommended to receive additional funding was
24	calculated by multiplying the cost per customer of providing RESEA services (\$134.78) by
25	the difference in RESEA profile pools between BCY 2024 and BCY 2025.
26	the difference in reason profile poorly between Bell 2021 and Bell 2023.
27	Earlier this year, Cameron County received a distribution of \$109,501 via a Workforce
28	Contract Action Request to provide RESEA services to a dramatically larger profile pool
29	due to a mass furlough in the area. Therefore, the recommended distribution for this Board
30	has been reduced by that amount.

32	Decision Point
33	Staff recommends amending the BCY 2025 contract to distribute \$1,382,513 to Boards for
34	the provision of services to additional customers in their profile pools, as listed in the chart
35	below, as well as requiring that funds be expended by February 28, 2026. The distribution
36 37	will be funded with \$1,298,407 from the FY 2024 Performance Outcome Payment and \$84,106 from prior year RESEA grant balances.
