

MEETING OF THE TEXAS WORKFORCE COMMISSION

JUNE 24, 2025

1	Tuesday, June 24, 2025
2	CHAIRMAN DANIEL: Good morning. Morning?
3	Yeah, good morning, all. This meeting is called to order. Mr.
4	Trobman, has anyone signed up for public comment?
5	CHAIRMAN DANIEL: All right.
6	CHAIRMAN DANIEL: The motion passes with the
7	exceptions noted. We'll take a short recess.
8	MS. GONZALES: Thank you.
9	CHAIRMAN DANIEL: All right, we're back.
10	This is Agenda Item 9, distribution of RESEA performance outcome
11	payments.
12	SUZETTE ROBINSON: Good morning, chairman,
13	commissioner, and Mr. Serna. Texas has earned performance
14	outcome payments every year since 2022. The commission has
15	approved to distribute these funds to local Workforce
16	Development Boards as performance and training incentives based
17	on how well they provide services to customers. Staff is
18	presenting for your consideration the performance outcome
19	distrib-payment distribution. The discussion paper includes
20	three decision points. Decision point one: Reallocating to
21	Panhandle, Concho Valley, and Deep East \$125,202 from the
22	previous year incentive. Decision point two: Allocate roughly
23	1.6 million to all 28 boards as performance and training
24	incentives, and decision point three: Allocating approximately
25	1.3 million to boards experiencing higher than normal profile

1	pools, and the remaining balance of a whopping \$8,293 to TWC for
2	RESEA administration. Staff recommends the commission approval
3	of the performance outcome distribution consistent with the
4	decision points, and I'm happy to answer any questions.
5	CHAIRMAN DANIEL: Any comments or questions?
6	COMMISSIONER TREVIÑO: None here.
7	COMMISSIONER ESPARZA: No questions,
8	chairman.
9	CHAIRMAN DANIEL: All right. On issue one,
10	so these three boards, they did not spend their money during the
11	contract year they were supposed to spend their money and so
12	we're giving them the money back, is that what we're doing
13	there?
14	SUZETTE ROBINSON: Correct.
15	CHAIRMAN DANIEL: OK. On decision point two,
16	I just want to make sure I understand this chart correctly. It
17	looks like 16 of 28 boards did not get to at least 70 percent
18	less than half the time. Is that correct what I'm seeing?
19	SUZETTE ROBINSON: That is also correct,
20	sir.
21	CHAIRMAN DANIEL: 57 percent of the boards
22	did not get at least 70 percent of their work done more than
23	half the time. And then in issue item three, most of the boards
24	on this list that are getting additional money are the boards
25	that didn't get their work done at least half the time on the

1	list before. So the boards that did do a good job like I think
2	we had several 10-month winners. I don't think we had any-oh,
3	there's an 11. I don't see any of them on this list. Just help
4	me understand real quick why we're giving extra money to boards
5	that can't get their work done when there are boards that get
6	their work done or help me understand it if I'm not
7	understanding it correctly.
8	SUZETTE ROBINSON: So, for decision point
9	three, the boards that are getting the additional funds, it's
10	because they've had more than a 10 percent increase in customers
11	in the profile pool. So in order for them to be staffed up to
12	provide the services because they have a larger influx of
13	customers, that's why we're giving them the money.
14	CHAIRMAN DANIEL: OK, so-but they're still
15	the boards that didn't get their work done on issue-on issue
16	item two.
17	SUZETTE ROBINSON: Yeah, and so we've been-
18	we work with those boards. We have been working with them one on
19	one to improve their, uh, failure-to-report rates so that they
20	are, uh, providing services to all the customers.
21	CHAIRMAN DANIEL: OK. Thank you. Any other
22	questions?
23	COMMISSIONER ESPARZA: Uh, would there be an
24	opportunity to recalculate those that are, that are like you
25	

1	pointed out, are, are conducting like business using the
2	resource. There may be reasons why, uh-
3	CHAIRMAN DANIEL: Yeah, I don't know.
4	COMMISSIONER ESPARZA: The attention doesn't
5	go directly to the other-to the folks that aren't making-I guess
6	making their 70 percent completion rate.
7	CHAIRMAN DANIEL: Yeah, there's like five,
8	there's like five boards that didn't complete 70, at least 70
9	percent in any month, zero months, and a good chunk of them are
10	on this decision point three list as well. I understand it's two
11	different things. Yeah, I don't know. I think it's an up or down
12	vote today.
13	COMMISSIONER ESPARZA: When would the-when
14	does this-when does the funding get reallocated? What's the
15	timing of this?
16	SUZETTE ROBINSON: So, once this-this will
17	actually be a change to their current board contract so as soon
18	as the commission passes the action because they have-we have to
19	spend this money, uh, by-we have to allocate it by the end of
20	December.
21	COMMISSIONER ESPARZA: OK.
22	CHAIRMAN DANIEL: All right, is there a
23	motion?
24	COMMISSIONER TREVIÑO: Chairman, I move that
25	we approve the Reemployment Services and Eligibility Assessment

1	program performance outcome payment distribution plan as
2	described in the discussion paper and presented today by staff.
3	CHAIRMAN DANIEL: Is there a second? All
4	right, the motion dies for lack of second. Um, we'll revisit
5	this issue. Let's get it put on the agenda for a subsequent
6	commission meeting. All right, thank you. Let's see. We've got
7	something on Agenda Item 10 here but I think we covered all of
8	that yesterday afternoon. There's nothing to bring back up.
9	We'll move on with the agenda. Is there a legis-nope, there's
10	not a legislative report today.
11	Mr. SERNA: They're in Washington.
12	CHAIRMAN DANIEL: They're in Washington?
13	MR. SERNA: Today.
14	CHAIRMAN DANIEL: Well, help us all.
15	MR. SERNA: Monitoring.
16	CHAIRMAN DANIEL: We sent Michael to
17	Washington?
18	MR. SERNA: And Tom.
19	CHAIRMAN DANIEL: Did Michael take his good
20	tie?
21	MR. SERNA: He probably did.
22	CHAIRMAN DANIEL: Probably did? Is there an
23	executive director's report today?
24	MR. SERNA: No sir, there's not.

1	CHAIRMAN DANIEL: Is there any other order
2	of business to come before the commission?
3	COMMISSIONER TREVIÑO: Uh, nothing here.
4	COMMISSIONER ESPARZA: No, chairman.
5	CHAIRMAN DANIEL: Hearing none, is there a
6	motion to adjourn?
7	COMMISSIONER TREVIÑO: Uh, chairman, I move
8	to adjourn.
9	COMMISSIONER ESPARZA: I second.
10	CHAIRMAN DANIEL: It's been moved and
11	seconded to adjourn, the vote is unanimous, and we're adjourned.
