REPORT SCOPE AND METHODOLOGY

Purpose

This report is prepared and submitted to the Texas Legislature by the Texas Workforce Commission (TWC), in consultation with local workforce development boards, in accordance with Texas Labor Code § 302.0191.

In alignment with this statute, this report provides a point-in-time snapshot of the following:

- The total number of active registered apprenticeship programs in Texas, categorized by North American Industry Classification System (NAICS) industries.
- The total number of active apprentices participating in those programs.
- The total occupational demand for each industry where an apprenticeship program may be established.
- Strategic, actionable recommendations to expand apprenticeship opportunities in emerging and high-demand industries that demonstrate significant employment need relative to their current number of active programs and apprentices.

Data Methodology and Enrollment Dynamics

The data presented in this report represents a specific point-in-time snapshot of registered apprenticeship activity in Texas, sourced from the U.S. Department

of Labor (DOL). The data extract was generated by the DOL on May 8, 2026, capturing active apprenticeship data through April 30, 2026.

Registered Apprenticeship programs are employer-driven, and they frequently operate on cohort-based enrollment cycles, admitting groups of apprentices at defined intervals rather than through continuous intake. As a result, point-in-time data will naturally reflect cyclical fluctuations as cohorts complete their training, and sponsors prepare for upcoming enrollment periods.

These enrollment dynamics can produce year-over-year data variances. For example, Table 2 reflects a decline in active apprentices within the Hospital subsector. A detailed program-level analysis confirms this variance is attributable to the timing of the data pull, which captured large training cohorts for two hospital sponsors that were active during the prior year's reporting period, which were not matched by similarly sized cohorts at the moment this year's data extract was pulled.



Industry Adoption and TWC's Strategic Role

While sectors such as construction, manufacturing, IT, and transportation demonstrate robust participation in the Registered Apprenticeship model, other high-growth industries, notably healthcare and residential care, show fewer active programs. This difference may reflect regulatory, operational, or structural factors that influence how readily the “earn while you learn” model can be integrated into certain fields. To support broader adoption, TWC and the DOL continuously work together to cultivate new program development leads through targeted outreach initiatives, industry convenings, and direct stakeholder engagement.

The expansion of Registered Apprenticeships operates within a framework of shared responsibility between the state and industry partners. Because Registered Apprenticeships are fundamentally employer-driven, programs must be designed, often sponsored, and sustained by the businesses themselves. TWC serves as a strategic facilitator, deploying funding and technical expertise in response to business-identified needs. As a result, agency investments remain aligned with occupations and industries where employers have demonstrated demand, readiness, and capacity to participate, and where the occupational tracks are formally recognized through the DOL Registered Apprenticeship approval process.

As the Texas economy evolves and the DOL recognizes new apprenticeable occupations, TWC will continue to adjust its support strategies. By prioritizing high-quality pathways that reflect verified business needs and align with federal standards, TWC ensures its resources advance measurable career progression and support long-term workforce development across the state.

EXECUTIVE SUMMARY: REPORT ON AVAILABLE APPRENTICESHIPS IN TEXAS, PROGRAM YEAR 2026

This report, required by Texas Labor Code §302.0191, provides an overview of active registered apprenticeship programs in Texas for Program Year 2026 (PY 2026) through April 30, 2026. This report details the current landscape of registered apprenticeship programs across the state, comparing a snapshot of active participation data against long-term labor market projections to ensure Texas continues to build a skilled workforce for both today and tomorrow.

The data is sourced from the U.S. Department of Labor-Office of Apprenticeship (DOL-OA) and reflects active Texas apprenticeships. Industry projections and occupational staffing patterns are sourced from the Texas Workforce Commission (TWC) Labor Market Information (LMI) department.

Key Findings

- **Active Programs and Apprentices:** As of April 30, 2026, Texas supports 1,015 active apprenticeship programs across 47 industry subsectors, training approximately 43,377 active apprentices.
- **Industry Concentration:** The apprenticeship landscape is heavily anchored by Specialty Trade Contractors (19,263 apprentices), Educational Services (6,001 apprentices), and Heavy and Civil Engineering Construction (5,853 apprentices). These sectors account for over two-thirds of

all apprentices in the state and have shown remarkable year-over-year growth (e.g. 53.6% increase in Heavy/Civil Engineering).

- **Alignment with Projected Growth:** Of the 25 industry subsectors projected to add the most jobs in Texas between 2024 and 2034, a majority currently utilize active apprenticeship programs.
- **In-Demand Industries:** High demand continues in industry sectors including health care, technology, construction, and skilled trades.
- **Emerging Industries:** Texas shows continued growth in technology, advanced manufacturing, and energy.

Recommendations

The report recommends continued efforts to:

- Collaborate with employers and other stakeholders to address training needs in emerging and high-demand industries.
- Continue to expand and increase access to pre-apprenticeship and youth apprenticeship programs.
- Monitor industry trends and align apprenticeship programs with evolving workforce needs, including a focus on emerging industries.
- Prioritize the development of apprenticeship programs in rural areas.
- Encourage the use of technology and online learning resources.

Changes Observed Between the 2024–2025 (PY 2025) and 2025–2026 (PY 2026) Reports

- **Increase in Number of Programs:** The number of active apprenticeship programs increased from 961 in PY 2025 to 1,015 in PY 2026, reflecting a growth of 54 programs or a 5.6% increase.
- **Increase in Number of Apprentices:** The number of active apprentices increased from 35,585 in PY 2025 to 43,377 in PY 2026, an increase of 7,792 apprentices equaling 21.9% growth.

Through continued collaboration with educators, employers, and local workforce boards, TWC remains committed to cultivating a dynamic and highly skilled talent pipeline that will drive Texas's economic prosperity for years to come.

REPORT ON AVAILABLE APPRENTICESHIPS IN TEXAS, PROGRAM YEAR 2026

Introduction

[Texas Labor Code §302.0191](#) states that the TWC must report on active registered apprenticeship programs in the state and make recommendations to expand the availability of apprenticeship programs in emerging and high-demand industries and occupations.



This report includes a description of the current apprenticeship landscape in Texas, an examination of high demand and emerging industries and occupations, and an overview of active apprenticeship programs meeting workforce needs. This report concludes with recommendations on how to expand apprenticeship programs in Texas.

The apprenticeship data sample used in this report is provided by the DOL-OA and reflects active Texas apprenticeships through

April 30, 2026. An apprenticeship program is considered active if it has at least one participating apprentice at the time of this report.

Industry projections and occupational staffing pattern data are sourced from the TWC Labor Market and Career Information department. Industries are classified using the North American Industry Classification System (NAICS), and occupations are defined using the federal Standard Occupational Classification (SOC) system.

Prior to publication, a preliminary draft of this report was shared with all Texas Workforce Development Boards to solicit their insights. The feedback provided by the Boards was carefully considered and incorporated into these findings to ensure this report accurately reflects and supports shared workforce development goals.

AVAILABLE APPRENTICESHIPS IN TEXAS

Active Apprenticeship Programs

As of April 30, 2026, Texas supported 1,015 active apprenticeship programs offering training in 47 industry [subsectors](#)¹. The industries range from construction and mining to education and real estate. A list of industries and the number of active programs is in [Appendix A](#).

Figure 1: Top 10 Industries with the Largest Numbers of Active Apprenticeship Programs



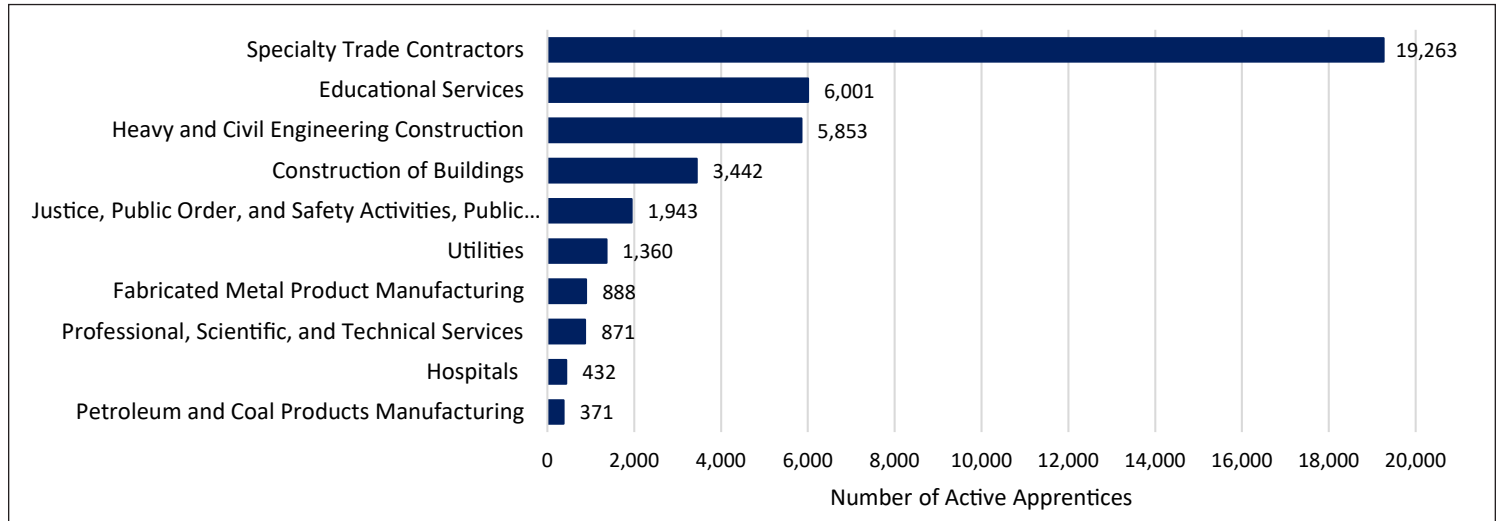
With 225 active apprenticeship programs, Specialty Trade Contractors (NAICS 238), which includes foundation, structure, and building exterior contractors; building equipment contractors; and building finishing contractors, makes up almost 22% of the active apprenticeship programs in Texas, followed by Educational Services (NAICS 611) at 20% and Heavy and Civil Engineering Construction (NAICS 237) at 13%.

¹Under the North American Industry Classification System (NAICS), a subsector is represented by a 3-digit code and serves as the second-highest level of the NAICS hierarchical structure. One way to envision this hierarchy is Supersector → Sector → Subsector.

Number of Active Apprentices

There are approximately 43,377 active apprentices in Texas. Apprenticeship programs within the Specialty Trade Contractor, Educational Services, and Heavy and Civil Engineering Construction industries contain over two-thirds of these individuals.

Comparisons: Numbers of Active Programs and Apprentices, May 2025 and May 2026

The 2026 report marks the third report on the Available Apprenticeships in Texas. With consecutive years of historical data for review, it is beneficial to compare numbers across the two reports and make note of any changes from one year to the next.

A comparison of the PY25 and PY26 DOL apprenticeship data reveals active apprenticeship programs experienced continued growth across key industry subsectors in Texas. Heavy and Civil Engineering Construction shows the addition of 31 programs in 2026, an increase to 130 active programs from 99 in 2025. This increase suggests an expansion of apprenticeship opportunities in this subsector.

²Justice, Public Order, and Safety Activities is a major government sector group under Public Administration (NAICS Code 922) that includes courts, police protection, and correctional facilities. It covers public programs designed to enforce laws, maintain social order, and manage legal or emergency operations.



The number of active apprentices also experienced marked growth across similar industry subsectors. Educational Services experienced continued growth, increasing by 12.8% (from 5,316 to 6,001 active apprentices). Similarly, Specialty Trade Contractors showed substantial growth with a 30.7% increase (from 14,738 to 19,263). Notably, Heavy and Civil Engineering Construction saw a dramatic 53.6% increase in apprentices (from 3,809 to 5,853).

The continued increases between 2025 and 2026 in most industry sectors may be attributed to a growing demand for skilled workers in both the private and public sectors, as well as the recognition that the apprenticeship training model is a proven strategy for addressing workforce shortages and supplying talent pipelines in Texas. This growth presents distinct opportunities for further development of tailored programs to address specific, regional workforce needs.

While the Hospital subsector displays a decline in active apprentices within Table 2, this variance is a direct reflection of the point-in-time data collection methodology rather than a reduction in industry demand or program availability.

Registered apprenticeship programs within the healthcare sector frequently operate on structured, cohort-based schedules with defined graduation and enrollment dates. Program-level analysis indicates that two major hospital sponsors had large training cohorts that were active during the prior year’s reporting period. Because the May 8, 2026 data extract captures activity only through April 30, 2026, the timing resulted in a temporary decrease in the “active” apprentice count.

As these and other healthcare sponsors complete their recruitment cycles and register subsequent training cohorts with the U.S. Department of Labor, active apprentice counts in this subsector are expected to realign with the state’s ongoing, high demand for healthcare professionals.

Projected Growth by Industry and Number of Apprentices per Industry

As detailed in the table below, there are active apprenticeship programs in Texas for a majority of the 25 industry subsectors projected to add the most jobs from 2024-2034. Currently, only seven high-growth subsectors do not have active programs. These seven subsectors are Warehousing and Storage, General Merchandise Retailers, Nursing and Residential Care Facilities, Securities and Commodity Contracts, Amusement, Gambling, and Recreation, Couriers and Messengers, and Accommodation.

Locations of Apprenticeship Programs

Because of the vastness of our state, 254 counties across 28 Workforce Development Areas (WDAs), it is helpful to examine the locations of active apprenticeship programs to determine if they are meeting the needs of the state's emerging and



in-demand industries and to consider ease of access for current and future apprentices.

Industry projections from TWC LMI provide critical insights into the evolving economic landscape of the state, highlighting industries poised for significant growth and identifying those facing potential contraction. These projections, grounded in historical trends, occupational estimates, and economic forecasts, offer valuable guidance for workforce development initiatives, educational programs, and individual career planning. Analysis of TWC LMI data reveals a consistent demand for workers in sectors such as health care, technology,

construction, and skilled trades, driven by factors such as population growth, technological advancements, and infrastructure development. Understanding these in-demand industries is crucial for ensuring a skilled workforce prepared to meet the future needs of the Texas economy.

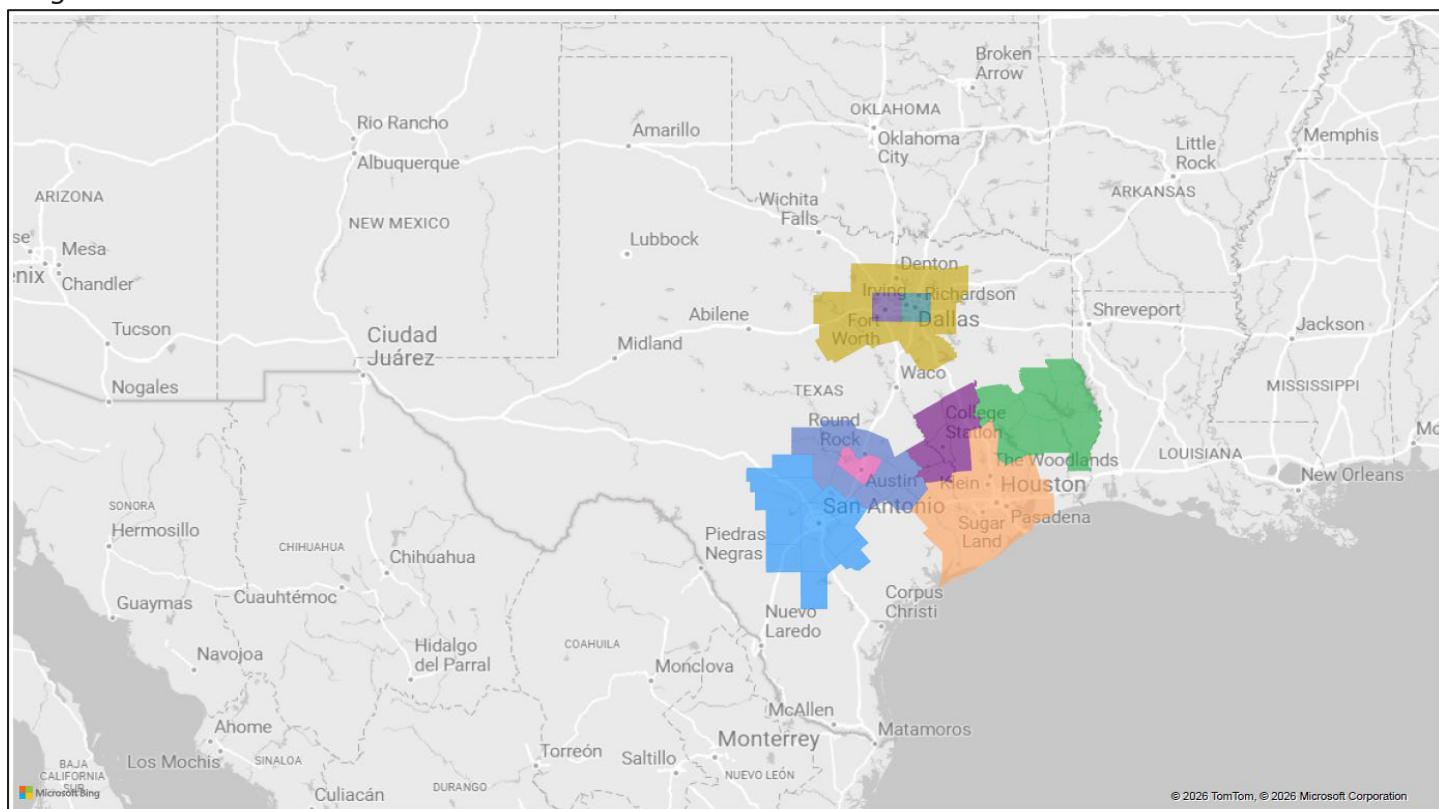
While the current data shows a strong foundation of apprenticeship programs statewide, a review of their geographic distribution reveals that these opportunities cluster within major metropolitan centers, possibly leaving some rural and less-populated WDAs with limited access to local training pathways.

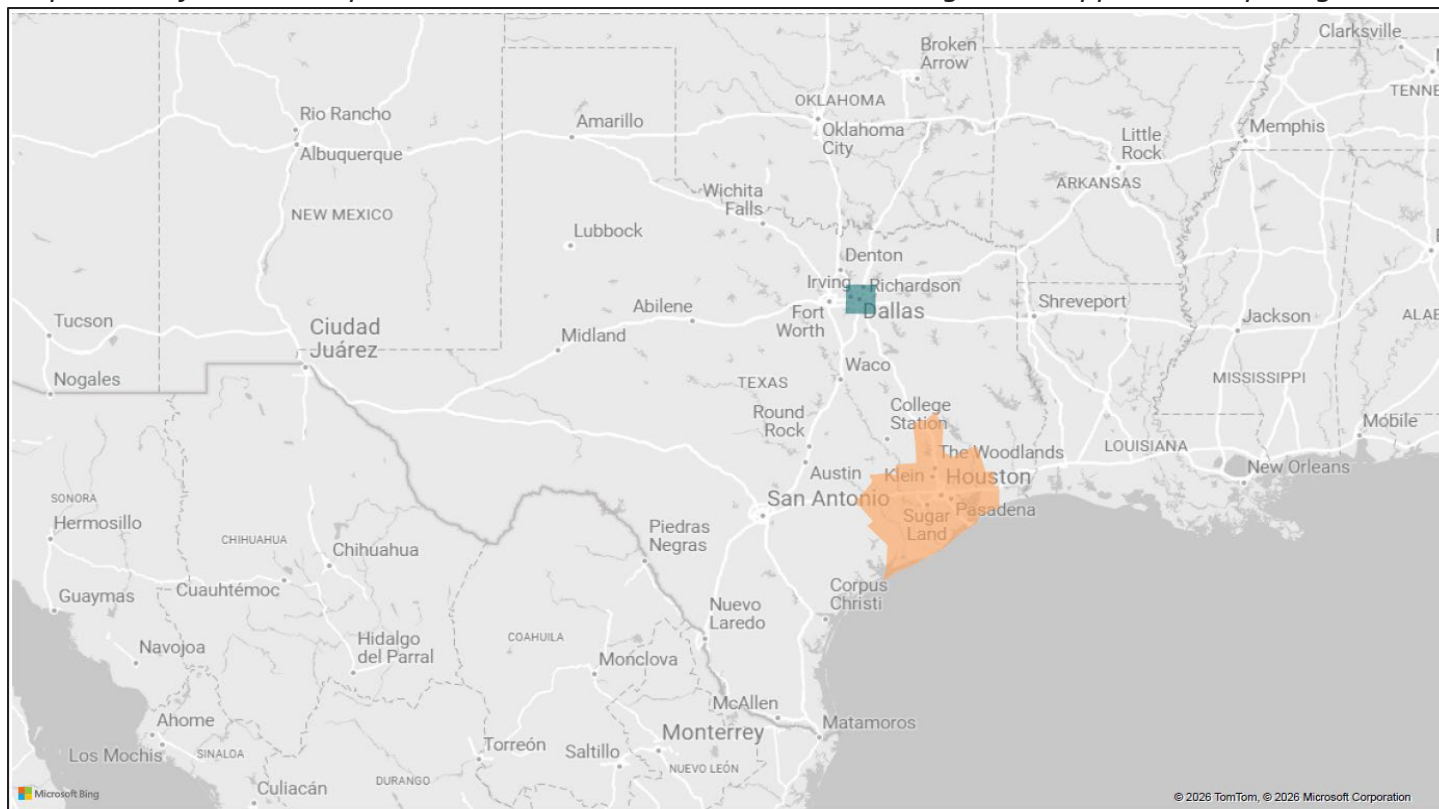

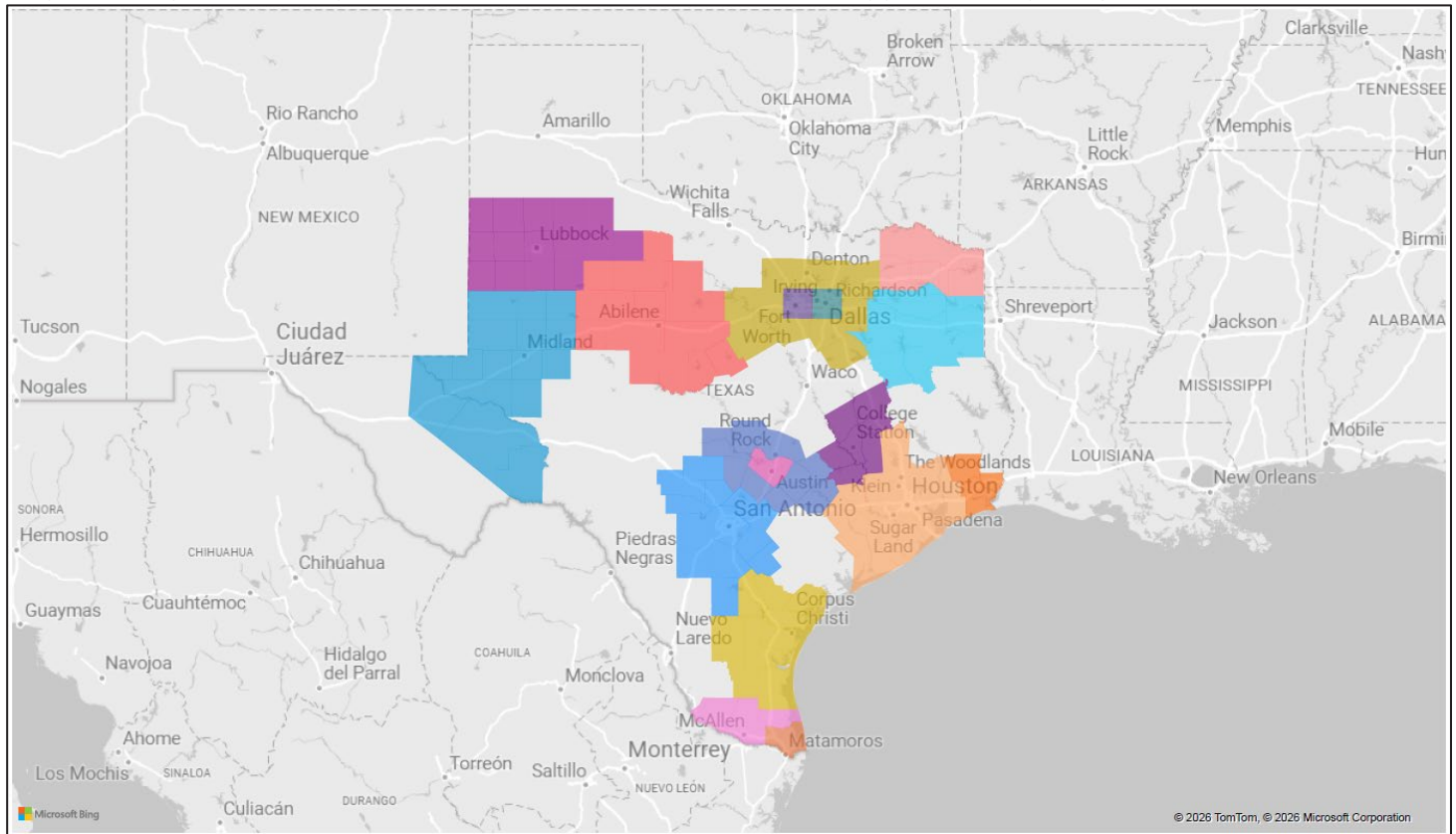
Map 1. Workforce Development Areas with Professional, Scientific, and Technical Services Apprenticeship Programs



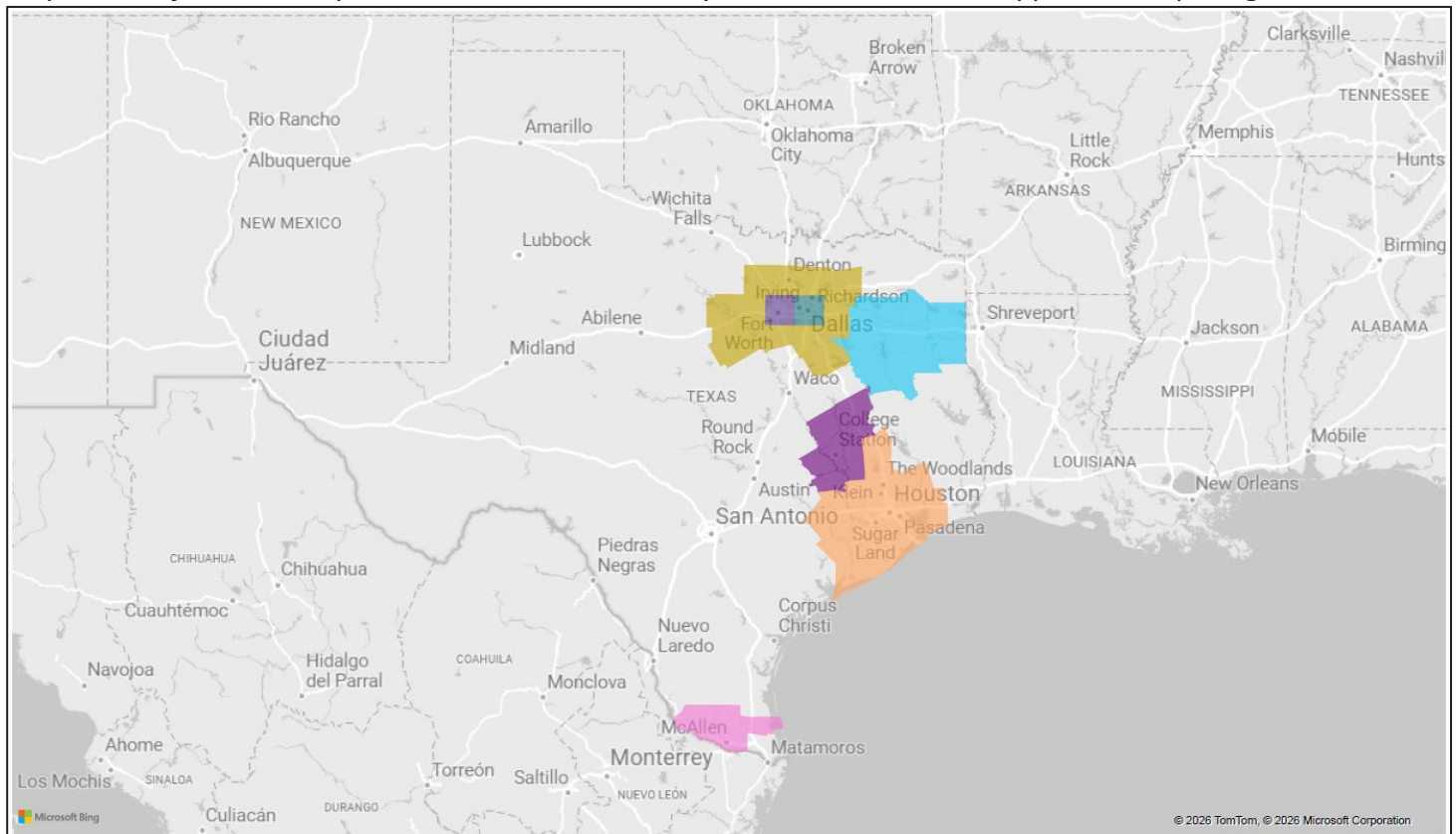
Map 2. Workforce Development Areas with Food Services and Drinking Places Apprenticeship Programs



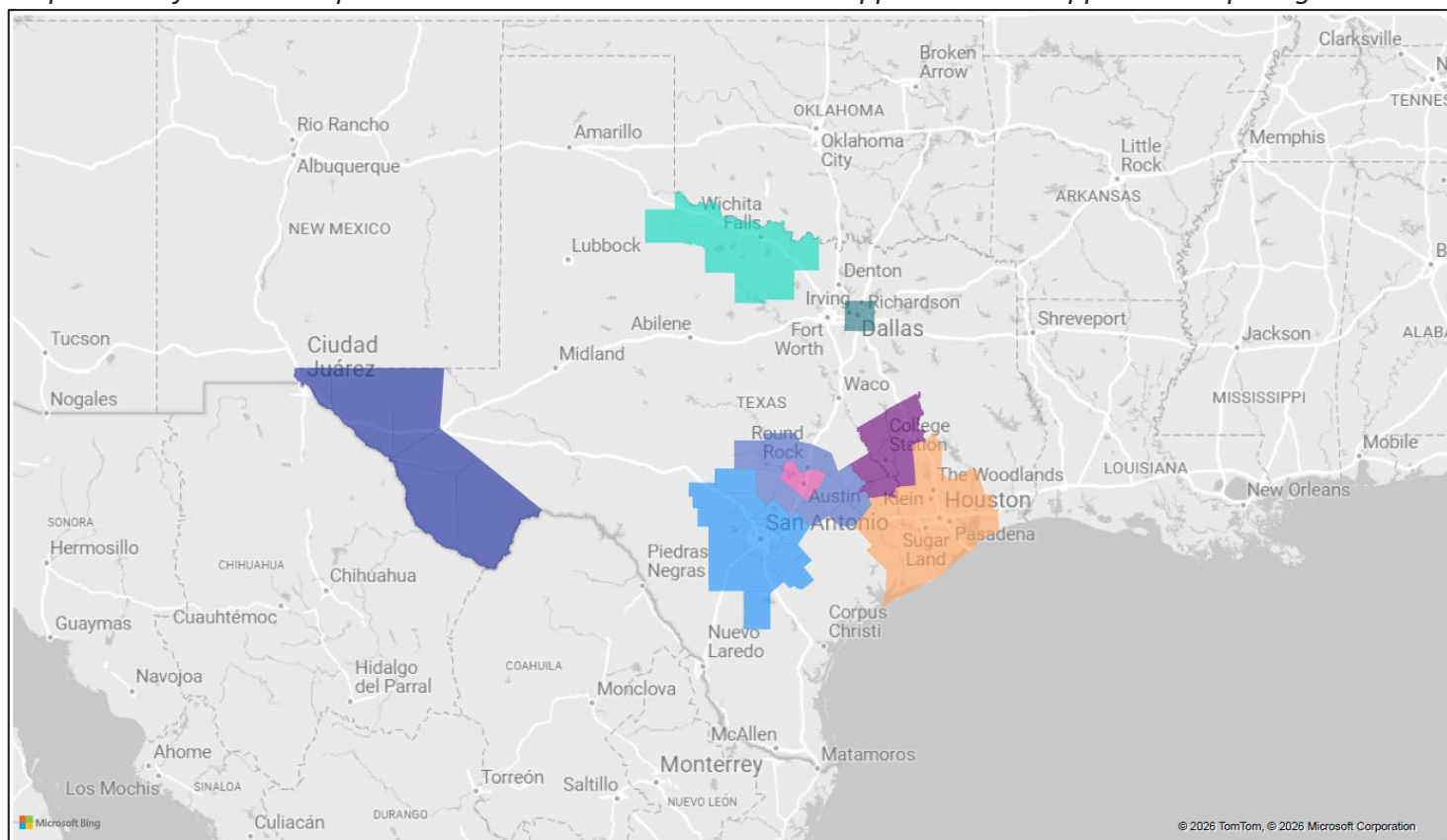
Map 3. Workforce Development Areas with Educational Services Apprenticeship Programs

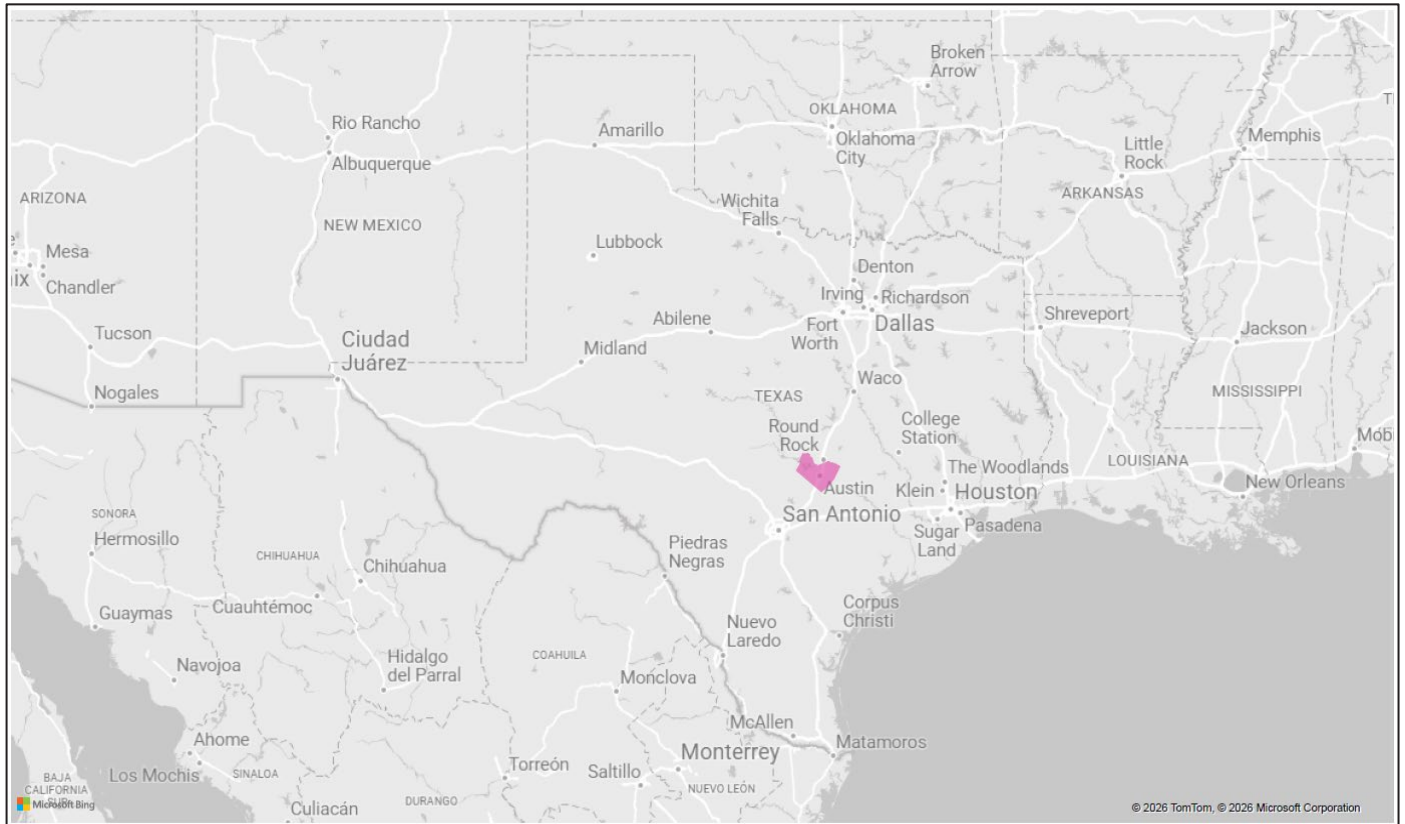

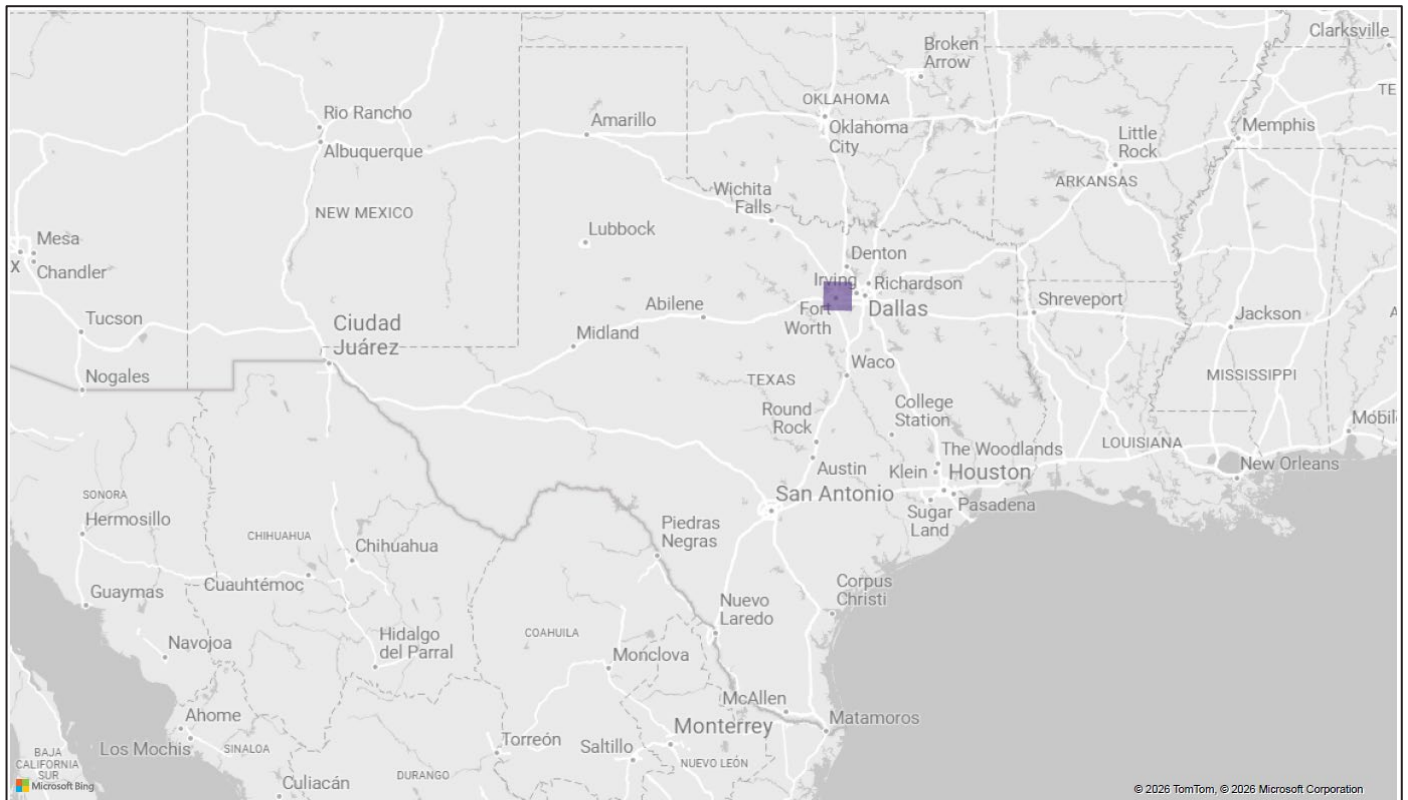

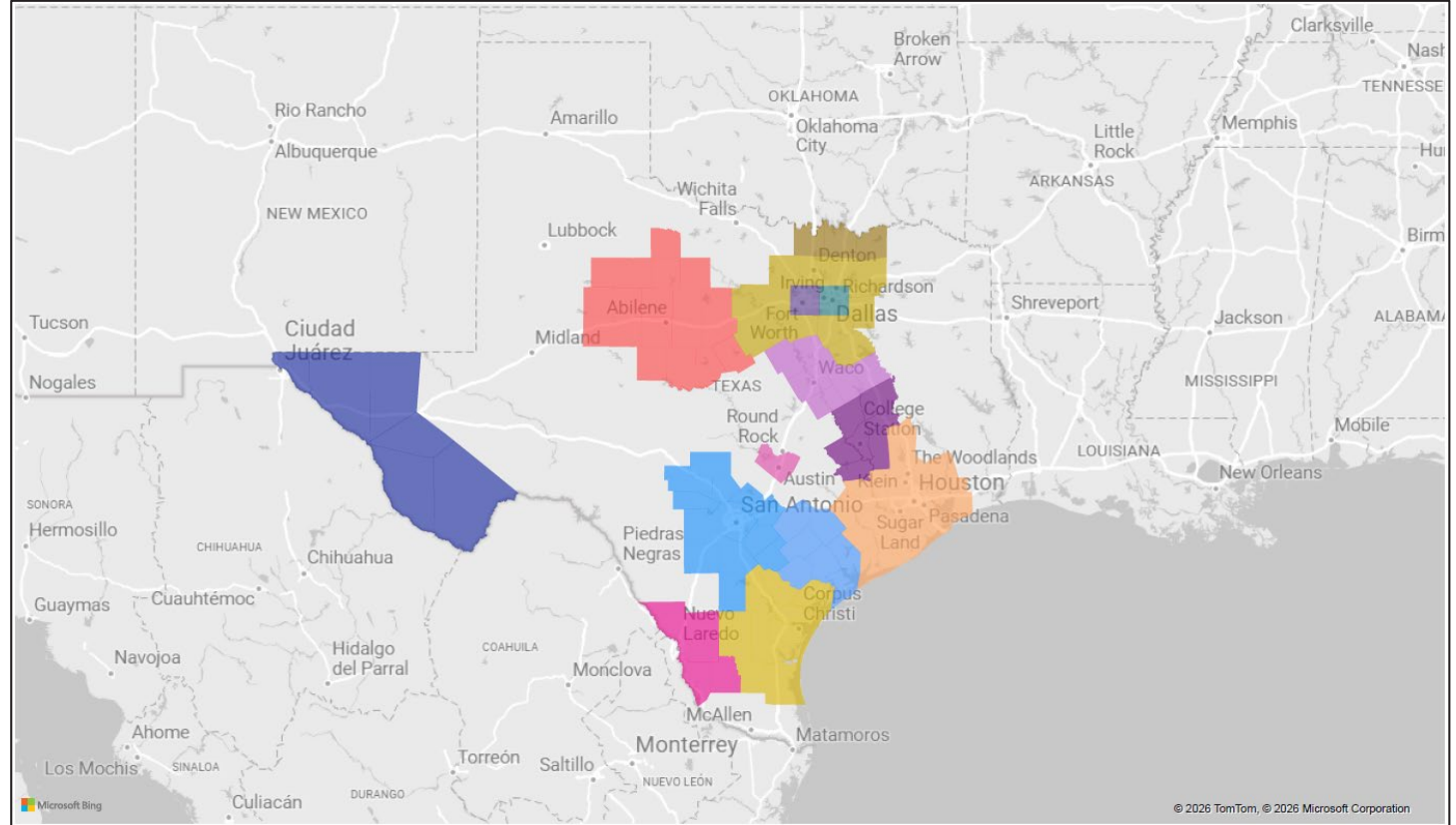
Map 6. Workforce Development Areas with Computer and Electronic Product Manufacturing Apprenticeship Programs



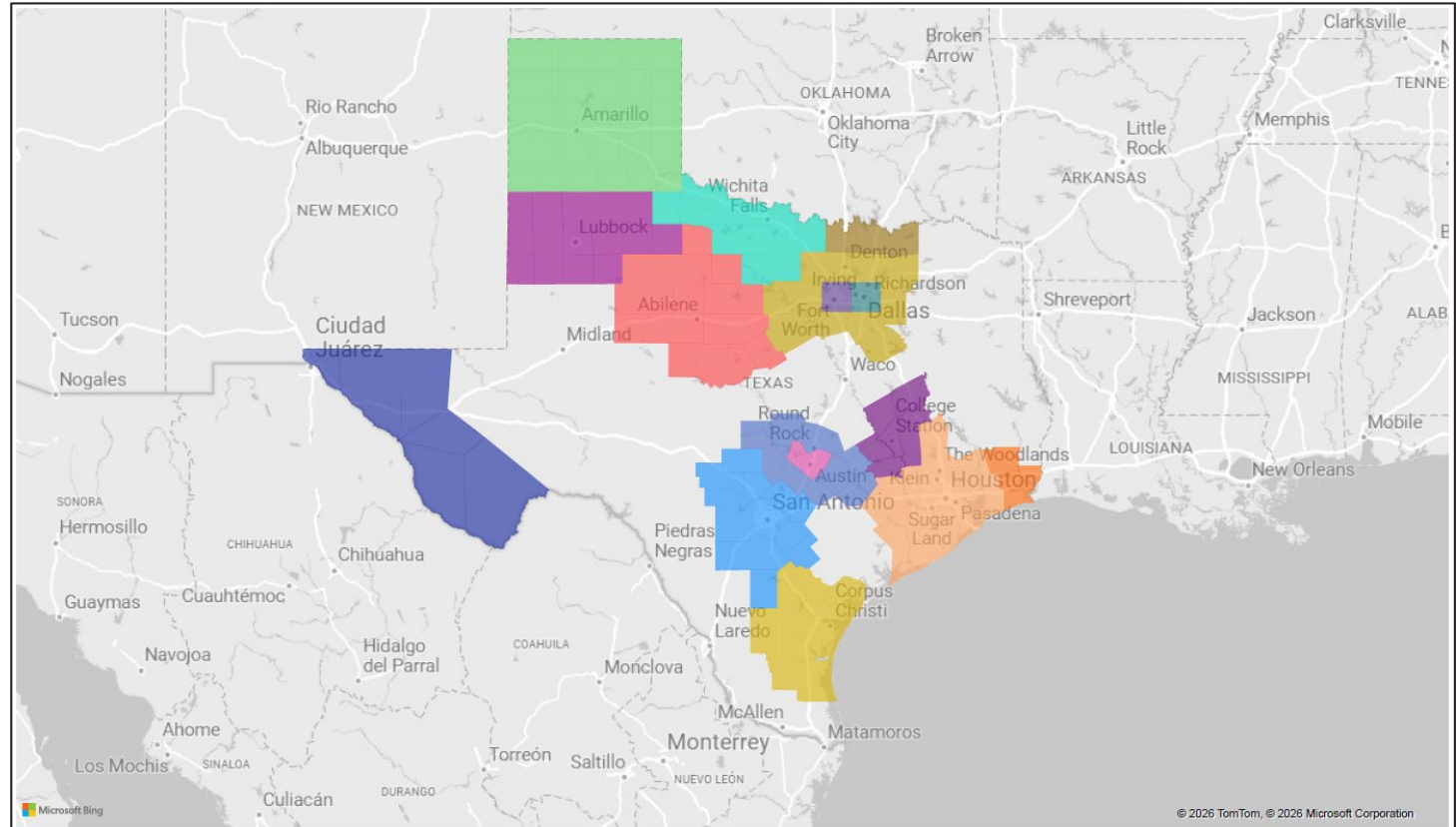
Map 7. Workforce Development Areas with Data Processing, Hosting, and Related Services Apprenticeship Programs



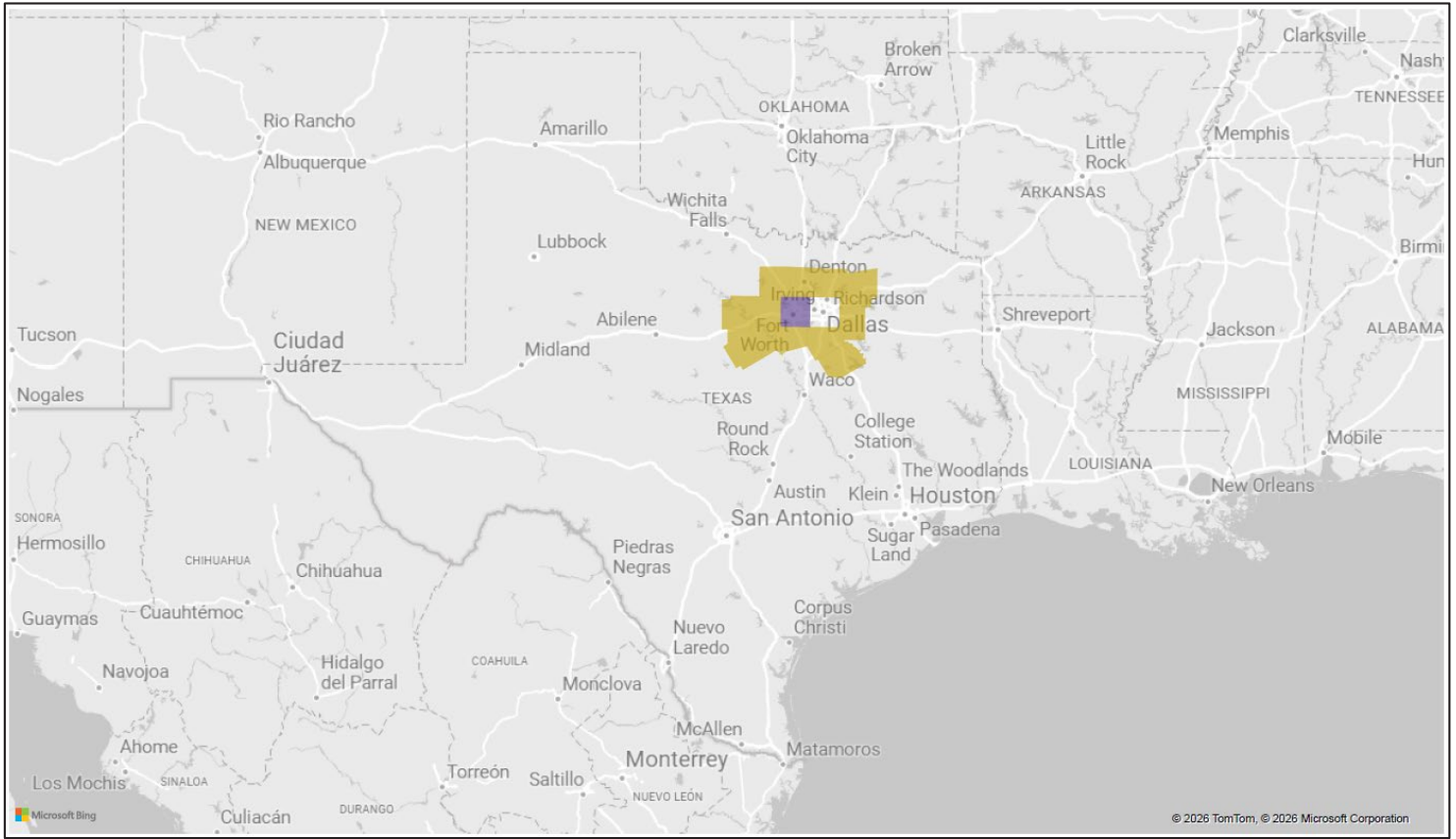
Map 8. Workforce Development Areas with Construction of Buildings Apprenticeship Programs

Conclusion and Recommendations

When measured in the context of numbers of active apprenticeship programs and apprentices within the state's fastest-growing industries, Texas remains well-poised to respond to future labor market demands. The PY 2026 data underscore the proven effectiveness of established apprenticeship models in cultivating skilled talent pipelines. Industries within the Specialty



Trade Contractors and Heavy and Civil Engineering Construction subsectors continue to demonstrate a strong history of using this model to ensure a consistent supply of highly skilled employees. Also, the continued growth of apprenticeships in non-traditional

sectors, such as Educational Services, highlights a continued recognition of the “earn while you learn” model’s value in addressing labor shortages and building pathways to long-term careers for Texans.

TWC is committed to supporting apprenticeship programs across the state and offer value for Texas employers through a variety of ongoing initiatives including Apprenticeship Expansion, the Critical Skills

Initiative, the Health Care Apprenticeship Initiative, and Pre-Apprenticeship Pathways.

By leveraging TWC resources, employers can develop a highly skilled workforce while minimizing training costs. Efforts to build upon the success of existing apprenticeship initiatives and leverage the apprenticeship model as a comprehensive workforce solution for both traditional and non-traditional industry sectors should continue.

While the overall growth is positive, a review of the data highlights opportunities to introduce the apprenticeship model to new sectors and possibly re-engage with others. Recommendations for the expansion of apprenticeship programs to meet the specific employment needs of emerging and high-demand industries include the following:

1. **Healthcare Apprenticeships:** Partner with healthcare employers, hospitals, and local workforce development boards to build upon past successes and explore new pathways for nursing and other health apprenticeships, ensuring this sector is equipped to meet its high projected job growth.
2. **Untapped High-Growth Sectors:** Targeted outreach and education are the most critical components for the continued growth of apprenticeships that address the workforce demands of the state's emerging and high-demand industries. The Office of Apprenticeship currently performs these services and continues to proactively seek new opportunities to connect



with in-demand industries and employers. Therefore, it is recommended to continue and expand this targeted outreach and education for employers in high-growth subsectors that currently have limited or no active apprenticeships, familiarizing and assisting these industries with the process of designing and implementing programs that will meet their workforce needs.

3. **Tech and Advanced Manufacturing Pathways:** Work with the DOL-OA and industry leaders to fast-track industry-recognized training programs in emerging, high-wage fields like AI, cybersecurity, semiconductor manufacturing, and data processing.
4. **Youth Access:** Continue to increase access to pre-apprenticeship and youth apprenticeship programs by expanding partnerships with school districts and community colleges.
5. **Geographic Distribution:** Study the geographic distribution of programs to support development in rural areas, utilizing online learning and other technology to ensure access to training and employment opportunities across all 254 counties.
6. **Explore new strategies to collect feedback from workforce development boards, employers and other workforce development partners.**

TWC will continue to work collaboratively with new and existing apprenticeship programs to promote growth, inspire innovation, and ensure successful, sustainable apprenticeship models that meet the evolving needs of the Texas economy.
