On July 1, 2019 and July 1, 2020, TWC was awarded Apprenticeship State Expansion Grants from the U.S. Department of Labor Employment and Training Administration (DOLETA) to expand RAPs throughout Texas. The funds are used to support statewide apprenticeship expansion efforts such as developing and implementing a variety of strategies to increase the number of apprentices in RAPs, increasing the diversity of apprentices, expanding apprenticeship opportunities in new industries, and increasing capacity to support the development and oversight of apprenticeship programs statewide.
