

Program Year 2020–2021 Performance-Based Funding Criteria

This table outlines performance-based criteria and funds approved by the Texas Workforce Commission’s (TWC) three-member Commission (Commission) on October 27, 2020, including:

- funds released to grantees for the PY’19 high school equivalency (HSE) or Ability-to-Benefit Enrollment/Achievement measure;
- funds to be released to grantees for meeting the performance-based criteria for the third quarter retention measure, as described in this AEL Letter; and
- the PY’21–’22 performance-based holdback to be determined when the Commission approves the PY’21–’22 allocations for AEL, in summer 2021.
