

Subject: BCY 21 Child Care Local Match Agreements

Date: October 6, 2020 Commission Meeting

Issue: Acceptance of BCY 21 Child Care Local Match Agreements from the Boards.

Facts:

Annually, local workforce development boards submit local match pledges to secure federal child care funds pursuant to Commission rule §809.17. This will be a standing agenda item, as Boards may continue to submit match agreements through January 31, 2021.

Staff requests Commission acceptance of child care pledges for donations, transfers, and certifications of expense for BCY 21 in the amount of \$678,000.

- Two (2) boards have secured a portion of match with one (1) securing at least 50% of the total.
- Boards have secured 1.64% of the statewide child care local match target compared to 5.04% at this time last year (10/29/2020).
