- 5 Texas Labor Code, §315.005, and Texas Administrative Code §805.43 require the Texas
- 6 Workforce Commission (TWC) to establish an Adult Education and Literacy (AEL) advisory
- 7 committee. The advisory committee must not be composed of more than nine members and must
- 8 include at least one representative of the business community and one representative of a Local
- 9 Workforce Development Board (Board). Members must serve for staggered two-year terms and
- 10 may be reappointed to a second term by the Commission.

11 Issue

- 12 Two committee members' terms ended in December 2020; these members represented AEL
- 13 providers. At this time, the Commission may appoint two members to fill these vacancies.
