TWC Chapter 806 Purchases of Products and Services from People with Disabilities §806.41 establishes requirements for participation in the program and subsequent adherence to those requirements when a CRP has been certified. CRPs must reapply every three years, before the expiration date on the certificate PPD staff reviews each completed application and all required documentation and, once the materials are deemed acceptable, presents the applicants to TWC's three-member Commission for approval.
