6	On June 30, 2021, the Texas Workforce Commission's (TWC) three-member Commission	
7	(Commission) held a work session on statewide initiatives and earmarked funding for a series of	
8	comprehensive statewide strategies. The Commission directed staff to research multiple	
9	initiatives using statewide program funds for job creation, job preparedness, and/or job	
10	progression activities.	
11	To support these efforts, approximately \$3.7 million statewide Adult Education and Literacy	
12	(AEL) State Leadership Funds from Budget Year 2021 (BY'21)/AEL Program Year 2020–202	
13	are available for projects to meet critical workforce needs.	
14	Proposed Initiatives	
15	Proposed initiatives funded with AEL State Leadership Funds and the proposed method of	
16	distribution for each are as follows:	
17	Pre-Apprenticeship Bridge Program for Building Trades 1—\$500,000, Request for	
18	Applications	
19	This initiative would require grantees to provide remediated instruction to applicants entering	
20	building trades-related Registered Apprenticeship Programs (RAPs) to build and practice	
21	reading and math skills before transitioning into the first year of a RAP. Staff suggests issuing a	
22	Request for Applications (RFA) in which eligible AEL providers, as outlined in Workforce	
23	Innovation and Opportunity Act (WIOA) §203(5), are the eligible applicants. Grant activities	
24	will include reading and math support, workforce preparation activities, and digital literacy	
25	services to ensure that participants are prepared for the rigor of the RAP.	
26	Employer Engagement ² —\$1.2 Million, Request for Applications	
27	Applicants awarded this grant will be required to offer employees eligible to receive AEL	
28	services one of the following activities:	
29	Workplace literacy activities	
30	 Workplace literacy activities with employer-provided training

- Workplace literacy activities with integrated education and training, leading to an industry-recognized credential
- 3 Applicants for this RFA are eligible AEL providers, as outlined in WIOA §203(5), in partnership
- 4 with an employer. All grantees will be required to develop curricula for workplace programs as a
- 5 deliverable, which will be disseminated to workforce system stakeholders as educational
- 6 resources for job readiness and progression within the industry sector. In the June 30, 2021, work
- 7 session, the Commission requested that three awards of \$400,000 be awarded through this
- 8 initiative to build replicable models that can be shared statewide.
