1 TUESDAY, JANUARY 26, 2021 2 CHAIRMAN DANIEL: All right, good morning, 3 all. The meeting--4 COMMISSIONER ALVAREZ: On a sad note. 5 CHAIRMAN DANIEL: --Mr. Trobman--there he 6 is. 7 MR. TROBMAN: Good morning. CHAIRMAN DANIEL: Has anybody signed up for 8 9 public comment? 10 MR. TROBMAN: We do not have anyone 11 registered for public comment this morning. 12 CHAIRMAN DANIEL: Thank you very much, sir. 13 Good morning, Ms. Miller. 14 MS. MILLER: Good morning, sir. 15 CHAIRMAN DANIEL: Thank you. This brings 16 us to the end of Agenda Items 3 through 7, and I see Mr. Serna. 17 Mr. Serna, do we have an executive director's report today? 18 MR. SERNA: A very brief one. I wanna make 19 sure the commissioners are aware that we did have--I did conduct 20 an all-staff, all agency meeting last week using technology. 21 One of the up sides of the COVID pandemic is we've increased our 22 use of technology and was able to hold a staff meeting with all 23 of our staff. There were about 4,200 staff that signed on to 24 the live event, and so far about 700 have looked at the recorded 25 event. We had a few little technical glitches that we'll

1 continue to work through, but it is a good way for us to communicate information to all of our staff at one time, and I 2 3 intend to repeat it, perhaps, at least once a year, maybe twice 4 a year, just to keep our staff informed about what's going on in 5 their agency. So, that's all I had to report to y'all. 6 CHAIRMAN DANIEL: Thank you, Ed. Actually, 7 I think that's a phenomenal exercise, and one that I'm glad you 8 undertook. I know there were many staff very interested in what 9 you had to say, and that's the ultimate open-door policy, when 10 we can use technology to [inaudible] executive director agency-11 wide. I really appreciate what you've done there, and 12 appreciate all you guys are doing to keep everybody abreast of 13 the pace that we're keeping here at TWC, both with regard to the 14 pandemic and all the other work that we're doing as well. 15 much appreciated. 16 MR. SERNA: Yes, sir. 17 COMMISSIONER ALVAREZ: I agree with you, 18 Chairman. 19 COMMISSIONER DEMERSON: And--20 CHAIRMAN DANIEL: And while I've got you, I 21 had a couple requests. I'd like to make those now. 22 MR. SERNA: Yes, sir. 23 CHAIRMAN DANIEL: One is at the next 24 commission meeting, could we have our staff update us on all the 25 different measures we've taken with regard to COVID, all the

1 pandemic-related measures that we've taken. Just give us a 2 general update on where we are with those. Some have completed, 3 some are in progress, like our skills enhancement efforts. I 4 would just like a picture of sort of what we've done and where 5 we are, and what things are continuing into the future. I think it's useful for us to revisit that from time to time. 6 7 MR. SERNA: Yes, sir, we'll do that. 8 CHAIRMAN DANIEL: Yes, sir, thank you. 9 then the second request I have is could you ask staff to provide 10 a briefing to my office on where we are with both WIOA and TANF 11 funds that have been encumbered, obligated, or otherwise 12 promised, but not yet expended, so I can get a picture of some 13 fund balances and what projects will be occurring over the 14 remainder of this fiscal year, based on those encumbrances and 15 obligations? 16 MR. SERNA: Yes, sir, we can do that. 17 CHAIRMAN DANIEL: Thank you. 18 MR. SERNA: Probably won't take us more 19 than a week or two to be able to do that, and then we can share-20 21 CHAIRMAN DANIEL: Perfect. 22 MR. SERNA: -- the same information with the 23 other offices.

CHAIRMAN DANIEL: Absolutely.
