- Section 231 Activities: To develop, implement, and improve adult education and literacy under AEFLA § 231, including programs for Corrections Education and Institutionalized Individuals under AEFLA § 225; and
- b) Section 243 Activities: To carry out Integrated English Literacy and Civics Education
 (IELCE) under AEFLA § 243.
- Through this Grant Award, grantees will enhance the Texas workforce system by delivering
- 13 services that will assist:
- a) adults to become literate and obtain the knowledge and skills necessary for employment and economic self-sufficiency;
 - b) adults who are parents or family members to obtain the education and skills that are necessary to becoming full partners in the educational development of their children, and lead to sustainable improvements in the economic opportunities for their family;
 - c) adults in attaining a secondary school diploma and in the transition to postsecondary education and training, including through Career Pathways; and
 - d) immigrants and other individuals who are English Language Learners (ELL) in: (1) improving their reading, writing, speaking, and comprehension skills in English, and their mathematical skills; and (2) acquiring an understanding of the American system of government, individual freedom, and the responsibilities of citizenship.
